To obtain the birth certificate, you will need to provide the full name at birth, date of birth, place of birth, including name of hospital and city, father's name, mother's name, including maiden name, picture I.D. (i.e., state-issued ID card or driver's license of person making the request), and adoption papers if applicable. The fee is \$15)

Applicants must be a descendant of an original TNC shareholder or a Class B shareholder. Write in the name of the original or Class B shareholder from whom you are a descendant.
